

# Anti-dumping of solar panels





## Overview

Are crystalline solar cells affected by US anti-dumping duties?

The US Commerce Department set final countervailing and anti-dumping duty rates on Monday for crystalline solar cells and modules imported from four southeast Asian countries. Cells and modules from Vietnam, Malaysia, Thailand and Cambodia are affected. Importers have already been posting cash deposits for the duties since last fall.

What are the anti-dumping and countervailing duties on solar panels?

The countervailing and anti-dumping duties are in response to a petition that a group of seven solar panel manufacturers called the American Alliance for Solar Manufacturing Trade Committee filed with the US government in April 2024.

What is the Antidumping Investigation of solar cells from Malaysia?

Malaysia: Antidumping (A-557-830) The antidumping investigation of solar cells from Malaysia covers the period from April 1, 2023, to March 31, 2024. All import of the subject merchandise, except excluded merchandise, from Malaysia is covered by this AD investigation. Four out of the six mandatory respondents received an AFA rate of 81.24%.

What is the Antidumping Investigation of solar cells from Vietnam?

Vietnam: Antidumping (A-552-841) The antidumping investigation of solar cells from Vietnam covers the period from October 1, 2023, to March 31, 2024. All imports of the subject merchandise, except excluded merchandise, from Vietnam is covered by this AD investigation. 9 out of the 11 mandatory respondents received a rate of 82.65%.
