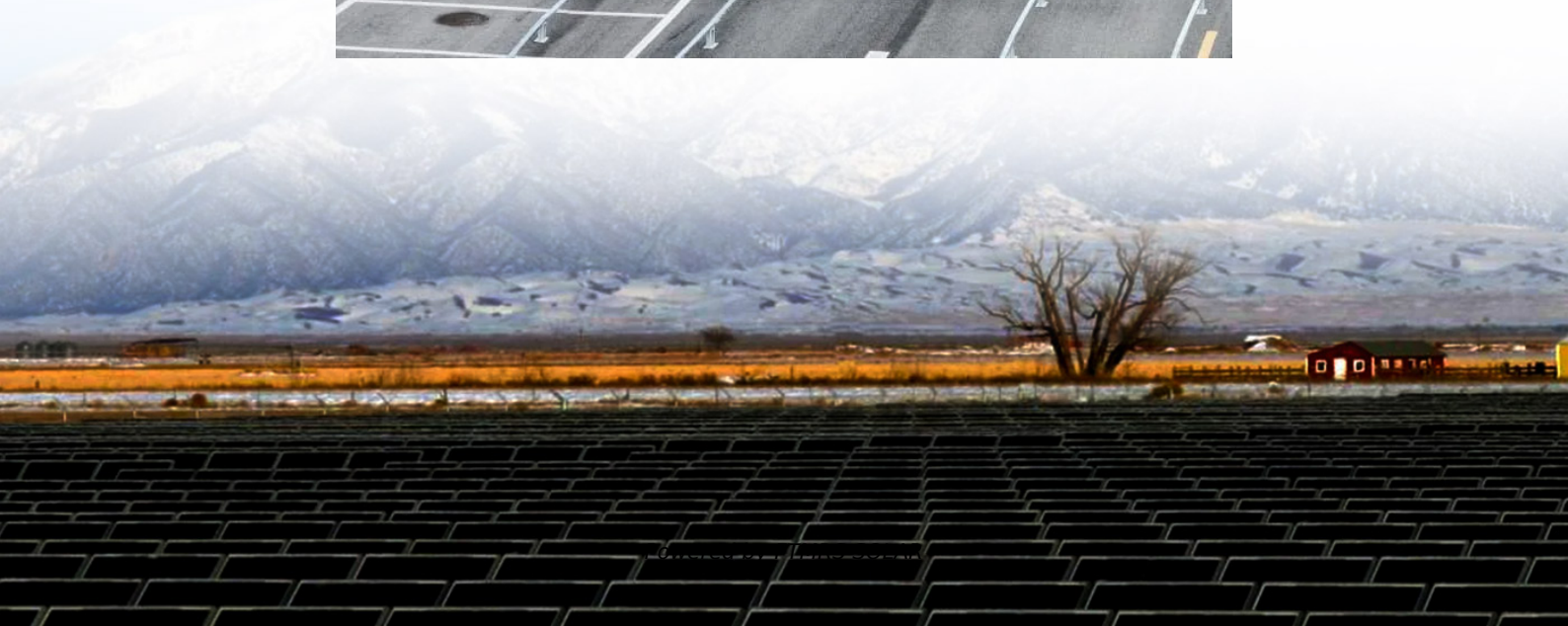


Compensation price for hitting solar panels





Overview

How much does solar insurance cost?

A survey of PV operators by Lawrence Berkeley National Laboratory in 2019 reported insurance costs of \$0.90/kW/year (Wiser, Bolinger, and Seel 2020). The website Solar Insure reports that property insurance premiums range from 0.15%–0.30% of installed cost, or approximately \$4/kW/year–\$10/kW/year (Solar Insure 2020).

What is solar insurance & how does it work?

Casualty insurance protects against liability for bodily injury or property damage to others, for example, caused by the PV system, such as by wind-liberated solar panels or fire caused by a problem with the PV system.

How much does a solar system cost?

At that time, the average cost of a PV system ranged from \$4,000/kw–\$6,000/kW, converting to approximately \$10–\$30/kW/year, making insurance one of the major expenses in operating a solar plant.

How much does a solar item claim cost?

Figure 3 illustrates that fire had the largest average solar item claim cost (\$17,308 per claim); followed by lightning (\$9,746); theft and vandalism (\$5,770); freeze, including ice and snow (\$5,288); and all other weather (\$3,702), all with larger average solar item values per claim than either hail or wind, which caused the most frequent losses.
