New 301 solar tariffs and trade investigations are likely to increase prices in the solar industry, especially on certain solar brands.

How will tariffs affect the solar industry?

Imported solar panels will likely receive price increases due to the new tariffs, which may affect pricing of the entire US solar industry. Even though our solar equipment is not directly affected by the proposed tariffs, the overall market may see price adjustments.

Is the solar industry insulated from tariffs?

Although the cost to install solar in the United States is higher than elsewhere in the developed world, the industry continues to grow in the U.S. The good news is that there has been significant investment in solar manufacturing in the U.S., so the industry is somewhat insulated from the impact of tariffs.

What are China's new tariffs on solar products?

The newly increased tariffs on imports from China, effective as of September 27, 2024, specifically target products vital to the solar industry: Solar cells and modules: Tariffs have doubled, increasing from 25% to 50%. Lithium-ion batteries: For electric vehicles, these batteries now face a tariff of 25%, up from 7.5%.
