Are lithium batteries shipped in a container?

There are three packaging categories for lithium batteries if they are being shipped in a container. When shipping lithium batteries, it is crucial to check the rules and regulations ahead of transportation, or work with an experience shipping partner to ensure that your cargo is shipped following best practices.

How are lithium ion batteries packed?

This applies for both lithium-ion cells and batteries and lithium metal cell and batteries. E.11 I have lithium-ion batteries packed with equipment (PI 966, Section I) where the lithium ion batteries are packed in a UN specification fibreboard (4G) box and then that box is packed with the equipment in a fibreboard outer packaging.

What is a section II lithium ion battery?

Section II Lithium-ion cells and batteries with a Watt-hour rating in excess of 2.7 Wh must be offered for transport at a state of charge not exceeding 30% of their rated capacity.
